<p>September 5, 2017 <i>(at least 31 days before the first public hearing)</i></p>	<p><u>Give written notice of the City's intent to annex the area to:</u></p> <ul style="list-style-type: none">• each property owner in an area proposed for annexation, as indicated by the appraisal records furnished by the appraisal district for each county in which the area is located;• each public entity, as defined by Section 43.053,* or private entity that provides services in the area proposed for annexation; <p>*Section 43.053 provides that a public entity includes a municipality, county, fire protection services provider, including a volunteer fire department, emergency medical service provider, including a volunteer emergency medical services provider, or a special district as that term is defined by Section 43.052.</p>
<p>Between August 8, 2017 and September 25, 2017 prior to date of published notice <i>(Prior to date of published notice)</i></p>	<p><u>Prepare service plan</u></p>
<p>Between September 24th and September 28th <i>(20th day to 10th day before the date of the first public hearing)</i></p>	<p><u>Publish notice</u> of each the public hearings (first and second) in the Polk County Enterprise a newspaper of general circulation in the City and in the area proposed for annexation (§43.063(c) - <i>publication of notice must be at least once on or after the 20th day, but before the 10th day before the date of the hearing</i>)</p> <p><u>Obtain from the newspaper</u> a notarized affidavit stating that each of the hearing notices was published.</p> <p><u>Post notice on the City's internet website</u> of each of the public hearings (§43.063(c)) - <i>notice must be posted on the website on or after the 20th day but before the 10th day before the date of the hearing, and remain posted until the date of the hearing</i>)</p> <p><u>Provide written notice of the public hearing to any school district in</u></p>

	the area proposed to be annexed (§43.905 - <i>written notice must be provided on or after the 20th day, but before the 10th day before the date of the hearing</i>) - <u>City may not proceed</u> with annexation unless it provides the required notice (§43.905(c))
October 6, 2017 <i>(at least 72 hours before meeting)</i>	<u>Post notice of public meeting</u> for first public hearing and second public hearing in accordance with Open Meetings Act
October 10, 2017 and October 17, 2017 <i>(after the 40th day but before the 20th day before the date of the annexation ordinance)</i> <i>(Council meeting)</i>	<u>Conduct first public hearing</u> and <u>conduct second public hearing</u> on proposed annexation (§43.063(a) - <i>hearings must be conducted on or after the 40th day but before the 20th day before the date of the institution of the proceedings</i>) <i>Scheduled at 6:00 p.m. at 372 FM 356 South in the City Hall Chamber Room.</i>
November 10, 2017 <i>(at least 72 hours before meeting)</i>	<u>Post notice of Council meeting</u> in accordance with Open Meetings Act
November 14, 2017 <i>(not more than 40 days after 1st hearing nor less than 20 days after 2nd public hearing)</i> <i>(Council meeting)</i>	Adopt annexation ordinance
Following adoption of Annexation Ordinance	File for preclearance with U.S. Justice Department; correct City map (notice to County); record annexation ordinance in County records
